



I. CALL TO ORDER

President Vaughn Mester called the meeting to order at 7:00pm.

II. PUBLIC COMMENTS

A. Public Comments
No comments

III. Public Hearing on Reorganization

Public hearing to hear petitions by Micah and Lori Bahr, Elam and Rebecca Allgyer, and Abner and Rebecca Allgyer to detach respective parcels of property from the Darlington Community School District and attach them to the Belmont Community School District.

Vaughn Mester called the Public Hearing Meeting to order and was identified as the Chairperson according to the board resolution setting the date and time for the hearing and Vaughn Mester's appointment as Chair.

Motion made by Jamie Heinrichs, second by Kim Schmelz for Laura Bahr to act as secretary. All aye, motion carried.

There was no objection to forgo reading the Notice of the Hearing.

All Belmont School Board Members were present: Kim Schmelz, Lauren Runde, Peter Bonin, BJ Galle, Jamie Heinrichs, Laura Bahr and Vaughn Mester.

Vaughn Mester read the statutory basis for making a decision. An overview of the petitions was given by Superintendent Beau Buchs. The parcels are closer to Belmont Community Schools. There are currently no students in the homes that attend public schools at this time.

Vaughn Mester reviewed the rules before testimony. No one was present to give testimony.

Vaughn Mester asked for discussion and action on a resolution to grant or deny the request of the territories described in the petitions. Laura Bahr made a motion, second by BJ Galle, to grant the transfer of the territory described in the petitions. That the reorganization requested in the petitions filed be granted and an order entered detaching the territories described in said petitions from the Darlington School District and attaching territory to the Belmont School District. Paper ballots for each petition were handed out by Laura Bahr. The results of the votes were as follows:

Petition by Abner and Rebecca Allgyer received 4 no votes and 3 yes votes. Motion to grant the transfer of the territory described in the petition denied.

A motion was made by Kim Schmelz, second by Laura Bahr to adjourn the Public Hearing on Reorganization at 7:22pm. All aye, motion carried.

A.School Board

Lauren spoke about the School Board Convention. She attended referendum workshops and school promotion through social media. She found it very worthwhile. Jamie found the information on referendums and school finance worthwhile.

Mrs. Bendorf prepared a written report. She would like to give a staff shoutout to Matt Wolch. Matt is doing a fantastic job in his first year at Belmont.

E. Superintendent

Mr. Buchs prepared a written report. He stated that staff continue to push forward and were working hard in the in-service today with a lot of collaboration. He also touched on the School Perception Survey.

A. Approval of Consent Agenda

Kim/Pete motion and second to approve the personnel transactions listed. Carried 7-0

C. Approval of Administrative Contracts

Laura asked if there were any changes to the contracts. Jamie stated that this is just saying we are moving forward with the same administration. Mr. Buchs stated that this is not approving pay increases, just that the board would like to continue with the administrative staff. Jamie/Vaughn motion and second to approve extending the Administrative Contracts for Brandon Wiese, Denise Brania, Dana Bendorf, and Beau Buchs for the 2024-25 and 2025-26 School Years. Carried 7-0

D. Approval of Tractor and/or Gator Purchase

The district needs something to use to drag the fields and do prep as well as snow removal. Mr. Buchs recommends purchasing a John Deere Gator and a tractor. BJ asked about the communication and decision from the committee meeting. Mr. Buchs stated that he is presenting what the maintenance staff is asking for to best do the job. Laura asked what we use the truck for and wondered if we would be able to sell the truck and use the funds for the tractor or gator. Brandon stated the truck is used for our shop class, extracurricular activities, and small jobs. Mr. Buchs stated that we could move items around on the budget and possibly use Esser Funds. Laura asked if the proposed tractors would be too heavy for dragging fields. Jamie stated that the gator would be about half the weight of the tractor and would be better for the fields. Pete said that he thinks we need to change the maintenance schedule and policies for equipment. Pete would also

like to set up a fee schedule with the village for equipment and hours worked at Bond Park. Mr. Buchs said that an agreement with the village was made last year and we have a plan in place to do this. Jamie asked how long the gator would last. Mr. Buchs stated that they do hold their value very well. Pete and BJ would like to see both options viewed by our maintenance team to compare. Laura asked if we could wait to decide. This will be tabled until the March meeting.

E. Approval of Lawn Care Bid

There were two bids for Lawn Care, Dan Tippett and Eggers Lawncare. BJ asked if we know how many times during the year we need to mow twice a week. Mr. Buchs stated that he believes there are usually 4 weeks that they would need to mow twice a week but it depends on the weather. Pete asked if we could ask to add in stipulations to the contract about missing mowing dates or not coming when a second mowing is needed.

BJ/Pete motion and second to accept the bid from Eggers as presented. Carried 7-0

F. Approval of Donations

The district has received donations of \$5,500 from Mound City Bank, \$5,000 from Jane Wedig, and up to \$8,000 from the Belmont Sports Boosters to pay for new scoreboards in the gym. The new boards would potentially be installed during the Summer. BJ asked if the total included installation. Mr. Buchs stated that they are waiting for the final quote to know for sure.

BJ/Lauren motion and second to accept the donations from Mound City Bank, Jane Wedig, and Belmont Sports Boosters as presented. Carried 6-0 Kim abstained.

G. Approval of Donation from JJ Mart

JJ Mart would like to donate \$1,000 toward the school to be used for the Pavilion. Jamie/Vaughn motion and second to accept a \$1,000 donation from JJ Mart. Carried 7-0

H. Approval of Scoreboard Purchase

Vaughn/Lauren motion and second to approve the purchase of new scoreboards for the HS Gym. Carried 7-0

I. Discussion and Approval of Paying for Neighbor's Property Damage

A neighboring property was affected by the water line break. Mr. Buchs has talked to our insurance company and there was/is not an option to purchase insurance for this type of break or damage. Jamie asked if we could set a standard payment since the district was not directly at fault. Vaughn suggested setting a policy for payment up to \$7,500 for damages. Laura stated that each situation is different and should be looked at individually. Jamie agreed that we set a small amount to be good neighbors. Jamie stated that if we redo the parking lot, we should consider looking at all the lines and possibly replacing the existing lines. Laura asked if there would have been a curb around the lot, it that would have stopped it from flooding the property. BJ stated that the main cause was there was about 2 feet of snow on the ground that kept the water from running a different path. BJ stated that he considers this an "act of God." He stated that if we were at fault from someone digging or we didn't perform maintenance, it would be a different circumstance. BJ stated that it isn't that we want to be bad neighbors, but the district is not at fault. BJ doesn't want to open this up to setting a precedent of covering anything small or big that happens to adjacent properties. BJ states that he feels bad about the damage, but it was an 'act of God' and not the fault of the school district. BJ/Pete motion and second to deny payment of \$7,248.65 to Jesse and Kristen Ramaker for their property damage. Carried 5-2

VI. Discussion Items

A. AGR Report

Mrs. Bendorf and Mrs. Brania prepared information on the AGR Report. We fulfill the grant by keeping our classroom numbers under 18. We need to keep track of our progress and have goals. There was a lot of movement between the tiers. BJ asked to see the track of one class of students from year to year. Mrs. Bendorf said that she does have this data compiled and can share it with the board members.

B. 2024 Referendum

Mr. Buchs discussed options for a referendum and stated that it may be better to look at a 4 year non-recurring referendum. If we decide to fix the front parking lot, he said we could ask for more in year one and two to pay for this while asking for less in year three and four. There are a few options on how this could be done. He would like to figure out what questions we should ask on a survey. Jamie said that he would like to ask about a capital referendum as well as an operational referendum on the survey. Mr. Buchs agrees with Jamie on surveying questions about both. Kim asked if the board would have more discussion on facility needs before we give a survey. Mr. Buchs stated that he will share draft questions with the board for feedback before sending out the survey.

C. Marketing the School District

Mr. Buchs asked the board if they had any ideas on marketing the school district. Kim asked if the Republican Journal had ever asked about writing guest columns. Kim said that the Platteville Journal showcases Platteville's Superintendent on items on Platteville School District. It would be a snapshot of the district or topics going on in the district. Lauren stated that Instagram is becoming a bigger_platform than Facebook. She is wondering if the school should get an Instagram account and connect it to the Facebook account. Kim said it would be great to have a snapshot of our district that are unique, such as average scholarship amount, small class sizes, supportive community, and items that highlight our district. She stated that we could do paid advertising on social media, newspaper, or google ads.

I. CALL TO ORDER

A. The meeting was called to order and the pledge of allegiance was recited.

II. DISCUSSION ITEMS

- 1. Presentation from Performance Services regarding future building projects & renovations: Jim Wede and Craig Stranathan from Performance Services shared a presentation on building ideas and concerns about our existing facilities. They presented through zoom and shared some ideas on spaces for any potential projects and ideas to make our elementary entrance safer and ideas on renovating spaces in the building. They also shared some ideas on what could work for a fitness center, daycare, and locker rooms. The board members shared that they would like to see a survey go to community members before looking any further at ideas. Mr. Buchs reminded the committee that this is free information and just food for thought for big picture ideas in the future.
- 2. Tractor & Equipment Needs to replace Old Tractor: Discussion took place regarding the need to replace our old tractor. We discussed a number of quotes that we collected on various models and sizes and also discussed the idea of a gator and a tractor. The Kubota presented itself as the best option and most affordable price for the 40 hp tractor. BJ & Pete suggested we look at a tractor first and discuss later on if this is not working to drag the fields. After discussion, BJ moved to purchase the 40 hp Kubota tractor with the loader, pallet forks, quick attach 3 pt. hitch and weights for the back. Pete seconded the motion and it passed 3-0.
- 3. Handicap Pavilion at Athletic Fields: Mr. Buchs shared that we have a donor who is willing to donate the remainder of the costs to complete the pavilion up to \$15,000 but they want the pavilion completed prior to the first baseball game. After discussion, the committee was hesitant to say this could be done in this timeline but want to complete this as soon as possible. Mr. Buchs said he would reach out to the donor to see their thoughts.



2024-2025 Full-Time Open Enrollment Regular Application Period for Wisconsin Public Schools

INFORMATION FOR PARENTS

YOU MAY APPLY FOR OPEN ENROLLMENT FROM FEBRUARY 5 - APRIL 30, 2024.

What is Public School Open Enrollment?

Wisconsin's public school open enrollment program allows parents to apply for their children to attend a school district other than the one in which they live. Applications may be submitted to up to three nonresident school districts if the pupil wishes to attend a brick and mortar school. There are no limitations to the number of open enrollment applications that can be submitted to a virtual charter school.

How and when may parents apply?

The open enrollment regular application period for the 2024-25 school year is from February 5-April 30, 2024. The application period closes at 4:00pm on April 30, 2024. Late applications will not be accepted for any reason.

Parents may apply online at https://dpi.wi.gov/oe.

Can I apply to a virtual charter school under open enrollment?

A pupil may only open enroll to an online/virtual school if: (1) the school has been created as a virtual charter school that meets the requirements of the charter school law [Wis. Stats. 118.40 (8)] or (2) the pupil is required to physically attend school on a regular basis in a school located in the nonresident school district on the days that school is in session. Other important things to know about applying to virtual charter schools:

- A virtual charter school is not homeschooling. Pupils attending virtual charter schools are public school pupils.
- You must know the nonresident school district in which the virtual charter school is located.
- You must know your resident school district to apply.
- A list of virtual charter schools may be found at https://dpi.wi.gov/parental-education-options/charter-schools/virtual-charter-schools.

Parents whose applications are denied may appeal to the DPI within 30 days of the denial. State law requires the DPI to uphold the school district's decision unless DPI finds that the decision was arbitrary or unreasonable. The DPI's decision may be appealed to circuit court.

Who may participate in open enrollment?

Pupils in kindergarten to grade 12 may apply to participate in open enrollment.

Open enrollment for prekindergarten, four-year-old kindergarten and early childhood education is limited. Parents should call their resident school districts to find out if their preschool-aged children qualify for open enrollment.

Can an application be rejected?

Nonresident school districts may deny an application if regular or special education space is not available for the pupil; special education or related services are not available; or if the pupil has been referred for a special education evaluation but has not yet been evaluated. Nonresident school districts may also deny an application if the pupil has been expelled during the current or preceding two years for certain violent conduct or if the pupil was habitually truant from the nonresident school district during any semester in the current or previous school year.

If there are more applications than spaces, pupils must be selected randomly, after giving preference to pupils already attending school in the nonresident school district and siblings of currently-attending pupils.

Some school districts establish waiting lists to fill unused spaces, but others do not.

Can a resident district prevent a pupil from leaving?

A resident district can deny a pupil's application for an invalid application (early or late application or missing information), ineligibility due to age (too young or too old), or if the resident district does not offer the same type of prekindergarten, four-year-old kindergarten, or early childhood program as the nonresident district or the pupil is not eligible for the program in the resident district. These are also reasons that a nonresident district can deny an application.

Can parents appeal if an application is denied? Must pupils reapply every year?

Once a pupil is accepted into a nonresident school district, the pupil may continue to attend that district without reapplication except that:

- The nonresident district may require a pupil to reapply one time—at the beginning of middle school, junior high or high school.
- A pupil may be returned to the resident school district if the special education required in a new or revised IEP is not available in the nonresident district or there is no space.
- A pupil who has become habitually truant in the nonresident district may be returned to the resident district.

Is there a cost for parents to participate in the open enrollment program?

There is no tuition cost to parents for participation in open enrollment. Parents of open enrolled pupils may be charged the same fees as resident pupils.

Who is responsible for transportation?

Parents are responsible for transporting their children to and from school.

If transportation is required in the IEP for a child with a disability, it must be provided by the nonresident district.

School districts may provide transportation to open enrollment pupils if they wish. Usually, if transportation is provided, parents must transport the pupil to a location in the nonresident district.

Low-income parents may apply to the DPI at the end of the school year for partial reimbursement of their transportation costs.



Can a parent select a specific school in the pupil's nonresident school district?

Yes. A parent may request a specific school or program in the nonresident district. However, assignment to the requested school or program is not guaranteed and your pupil may be assigned to a different school other than the one requested. It is up to each nonresident district to determine a pupil's school assignment.

Can an open enrolled pupil participate in sports and other extra-curricular activities in the nonresident school district?

Open enrolled pupils have the same rights and responsibilities as resident pupils.

Inter-scholastic athletics are governed by the Wisconsin Interscholastic Athletic Association (WIAA), which has rules concerning transfer pupils. Parents should check with the school district's athletic director about eligibility.

IMPORTANT OPEN ENROLLMENT DATES

February 5 - April 30, 2024

Parents must submit applications online or directly to the nonresident school district.

June 7, 2024

Nonresident school districts must send notices of approval or denial via US mail or email. If the application is approved, the school district must notify the parents of the specific school or program to which the pupil is assigned. If the application is denied, parents have 30 days to file an appeal.

June 14, 2024

Resident districts must notify applicants if the application is denied. If the application is denied, parents have 30 days to file an appeal.

June 28, 2024


Parents of accepted applicants must notify the nonresident district if the pupil will attend the nonresident district in the 2024-25 school year. If the parent fails to make this notification, the nonresident district may refuse to allow the pupil to attend the district.
