REFERENDUM ELECTION

TO: Electors of Belmont Community School District

NOTICE IS HEREBY GIVEN to the qualified electors of Belmont Community School District, Lafayette County, Wisconsin, that a referendum election will be held on Tuesday, the 5th day of November, 2024. The purpose of the referendum election is to submit the following question to a vote of the qualified electors of the School District:

“Shall the following resolution be approved?

RESOLUTION TO INCREASE REVENUE LIMITS
FOR
OPERATIONAL NEEDS


Be it resolved by the School Board of the Belmont Community School District, Lafayette County, Wisconsin, that the school district be authorized to exceed the revenue limit specified in Section 121.91(2m), Wisconsin Statutes by \$550,000 per year beginning with the 2024-2025 school year and ending with the 2027-2028 school year, for the non-recurring purpose of providing for the operational needs of the school district.”

A copy of the resolution directing submission of the question set forth above to the electorate and information regarding the School District boundaries may be obtained at the School District office located at 646 East Liberty Street, Belmont, Wisconsin.

He also stated that Mrs. Brania and Shelly have worked hard to complete paperwork for Transfers of Service. Mr. Buchs stated that he had

an anonymous individual interested in making a donation and one idea was to look at a sprinkler system for the fields since our current one broke. The district is researching different options and looking at costs.

VI. DISCUSSION ITEMS

A. Update on the Start of the 2023-24 School Year and Enrollment

There are currently 364 resident students in school and 381 students enrolled overall. We had 386 total students at our peak last year. There are 53 students who are open enrolled into the district, which down slightly from 56 at the beginning of last year. We have 41 resident students who are open enrolled out of Belmont. Our enrollment has kept fairly steady over the last 5 years.

B. Update on Finance and Levy Projections

Mr. Buchs is working on a draft version of the revenue limit worksheet. The assessment values of properties in Belmont District last year were roughly \$247 million. This year, the estimate received in August assessment value is roughly \$272 million. The final amount will come out in October. These assessments help calculate the mill rate. The July 1 estimated aid is projected for just over \$3 million, however some projections are stating less than that. This suggests that we will be up in funding from the state. If the referendum fails in November our Mill rate would be just above 6. If the referendum passes the mill rate would just be over 8. The projected increase in EAV is up substantially but this number is finalized in October. We will not know our state aid until October. Mr. Buchs also shared that we are funded at about 66% by the state. It is common to see anywhere between 63-70% for schools in our state.

C. Operating Referendum Information for November 5, 2024 Election

Mr. Buchs stated that he went to a CESA meeting recently to discuss referendums. The majority of the Superintendents that attended are asking for an operating referendum or building referendum. Jamie Nutter created a chart that shows the CPI Index over the past years to now. It also shows how the gap in funding has grown. Part of the gap is because of inflation. This is not just a Belmont issue; it is an issue in most CESA schools. Mr. Buchs shared the chart with the board. Mr. Buchs invites people who have questions or would like to talk about the possible referendum to reach out to him.

VII. PUBLIC COMMENTS

Tom Leitzinger stated that the number one question that he hears from others in the public about the referendum is 'What is the money going to be spent on?'

Dear Members of the Board of Education and Members of the Belmont Community School District:

We have continued to battle staff shortages and we are working hard to improve our instructional practices and curriculum. We have had our PK-3 Teachers complete the mandatory Act 20 Training on literacy. I am proud of the efforts that our School Board, Administrators, & Staff have put forth to meet the educational needs of our students.

In order to continue providing our students educational opportunities, the Belmont Community School District has made a financial commitment. The following budget document is the culmination of this year's commitment. There are two versions of the budget which will be determined by the operational referendum question on the November 5th, 2024 ballot.

Budgeting is a challenging process of matching revenues and expenditures of the school district. Wisconsin's funding formula uses revenue limits. We use the revenue limit worksheet as required by DPI and this tells us how much money we can levy for the school district.

This year's budget has been created in a way which helps all of our students learn. The budget represents a fiscal plan for the operation of the school district. The resources in the plan pay for employees, learning materials, maintaining the facilities, pays the district's debts, and provides extra-curricular opportunities for our students. We have designed our budget to be very conservative in estimating our revenues and have accounted for all known expenditures.

The 2024-25 budget is being presented as a sound fiscal document, which considers the needs of the district's students. It is the product of many dedicated individuals working together for the best interest of Belmont's children.

I am very proud to be Belmont's Superintendent of Schools. I take great pride in our community in which I live within. I will continue to do my best to ensure great educational opportunities for our kids while also being fiscally responsible. I look forward to a great year!

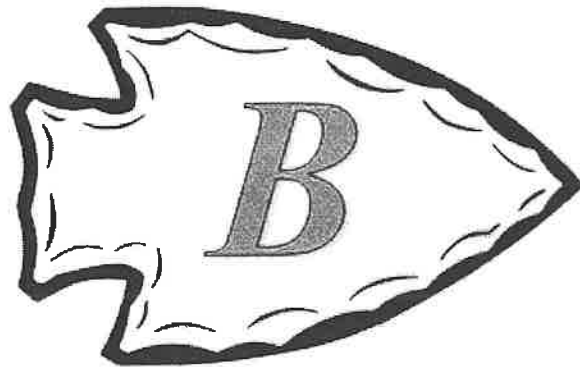

2024 Operating Referendum

On November 5, 2024, the Belmont Community School District will seek approval for an operating referendum to cover a shortfall in funding.

If approved, the referendum would allow the district to exceed state revenue limits by \$550,000 per year for four years for non-recurring purposes.

To ensure our community is informed ahead of the vote, we will be sharing data and information on the school website as well. We held one open meeting on August 22nd and we will hold another meeting on Oct. 16th at 7:00 pm.

Within the last four years, 28 of the 31 districts in our area will be pursuing referendums to balance their budgets. Just like most school districts in Wisconsin, we have been

working hard to manage the challenges of reduced revenue and rising expenses as we continue to try to invest in the future of our students and community.

Declining Revenue

Districts in the state of Wisconsin receive a large part of their revenue from the enrollments of students. The District's situation could be worse as a lot of local districts have declining enrollment. Belmont has held fairly steady with enrollment which has helped us be in a slightly better position than some of our neighboring districts.

During the three years prior to 2024 the federal government has been supporting schools through COVID - Esser grant funds that helped fill the gap in funding temporarily; however these funds were required to be spent this past year.

Increasing Expenses

Over the past three years inflationary costs have impacted every family in our school district. Specifically in our schools we have seen costs increase in these categories:

- Utilities
- Transportation Costs (buses & maintenance)
- Insurance
- Salaries
- Maintenance
- Supplies

Schools have also seen Consumer Price Indexes increase from 1.23 (2021), 4.70 (2022), 8.0 (2023), and 4.12 (2024). The four years prior to 2021 averaged a CPI of 1.91. These indexes show the inflationary impacts as related to how we compensate our employees to maintain competitive wages with our neighboring districts. Each of these past few years our staff has accepted increases in wages below the CPI levels in order to help our district balance our budget and maintain programming for our students.

How has the District worked to save on expenses?

- Switched Health Insurance Broker/Provider
- Updated Lighting in Parking Lot to save on utilities
- Staff Raises have been less than CPI
- Used Esser Grant Dollars to update outdated items
- Solicited Grants & Donations to lessen the tax burden
- Continue to Analyze Enrollment

We are asking the community to approve a \$550,000 operating referendum (each year for the next four years), which will meet most of our educational goals to operate and maintain basic levels of curriculum, technology, and maintenance needs. We are also aiming to fix our front parking lot and entrance which has a preliminary cost of around \$300,000. We also need to continue to update our bus fleet as well and an average bus now costs \$125,000+.

If the referendum passes, this would mean a tax increase of \$222 per \$100,000 home value. The Village of Belmont is also being reassessed this year so this could impact tax bills as well. Projecting the budget for the future is very challenging as CPI has been unpredictable over the past three years. Should CPI slow down, there is a good chance that we would not have to tax the full \$550,000 for all four years. The District is aiming to be responsible with spending as we face an uncertain future.

If the referendum does not pass, the district will need to short-term borrow in the near future to offset the deficits between our revenue and expenses. This will result in paying interest on every dollar that we borrow. We will also need to

eliminate programs and staff associated with those programs which will negatively impact the educational experiences for all in our community. We would then seek to approve an operating referendum at a future date.

To ensure that we are accountable to every dollar, the Belmont Community School District is audited on an annual basis. We're committed to providing a high quality education AND making sure every tax dollar is well spent!

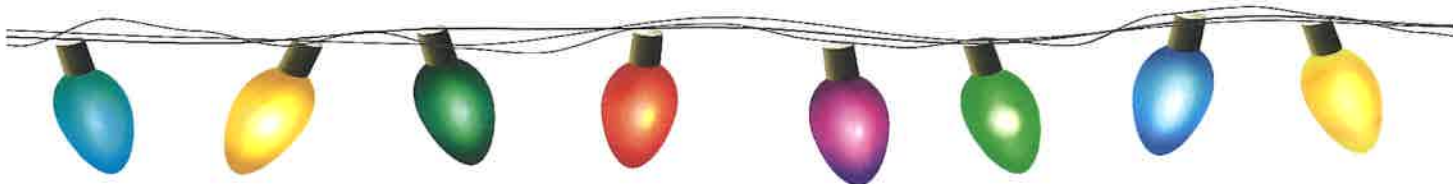

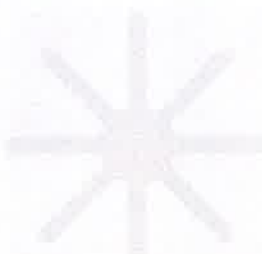

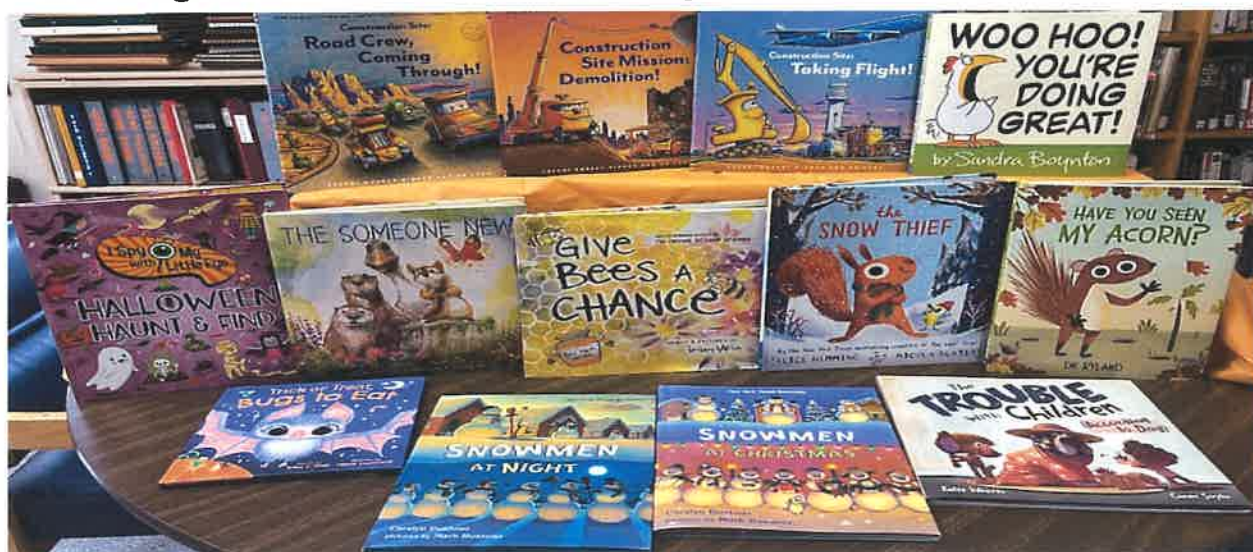
